- Click the drop down menu under "Credit Code" and select '136. Qualified Rural Hospital Org Expense'
- Fill in the fields next to the credit code, referencing Form IT-QRHOE-RHO1 ("RHO1 Form") that was emailed to you from Georgia HEART.

- On the 'Charitable Deduction for Qualified Rural Hospital Organization?' screen, you will select "No" as contributions to state income tax credit programs are no longer deductible as charitable contributions.
- Your contribution may qualify as a federal deduction only if you itemized deductions on your federal income tax return and had less than \$10,000 in state and local tax (SALT) deductions, whereupon you may deduct all or a portion of your HEART contribution as state income taxes up to the \$10,000 SALT limit.
- If you deducted any or all of your HEART contribution as state income taxes, select "Yes" and enter the amount that you deducted in the field that populates underneath.
- If you do not itemize, or if you met the \$10,000 SALT limit without including any of your HEART contribution, then you would select 'No' on this screen and would not add the amount back in taxable Georgia income.
- Select 'Continue'
