

2022 Tips for Claiming the Qualified Rural Hospital Organization Expense ("QRHOE") Tax Credit using H&R Block

- Go to the Credits section of the State Taxes section
- Select 'Other Credits'

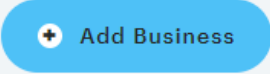

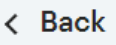

- Note: If you did not reach the \$10,000 maximum in SALT (state and local) tax deductions, you may deduct your rural hospital contribution (up to that \$10,000 SALT cap).
 - In this situation, please enter the contribution in the Federal deductions section for state and local taxes in order to take a deduction for your HEART contribution as “additional state income taxes paid.”
